

# 2016 Minnesota State Holstein Show Entry Form

Standard Agreement for owners to exhibit at Minnesota Holstein Association sponsored shows  
Must be signed and accompany an entry form complete with fee and a copy of the registration paper.

I agree I am personally responsible for the care, welfare, and condition of my animals during the period of the show. I acknowledge that I am responsible for my own action and failures to act and for the actions and failures to act and for the actions and failure to act of all of my employees and anyone else who assists me with the fitting, care, and show preparation of my animals.

I promise that I will abide by the Minnesota Holstein Association Show Ring Rules and the Minnesota Holstein Association Show Ring policy and Enforcement Procedures for dairy cattle, and any other show rules and regulations. I will also ensure that all of my employees, agents, contractors, and others who assist me with the fitting, care and show preparations of the animals comply with the same requirement. I understand that a failure to adhere to such requirements could result in disciplinary measures including possible suspension or ban of me, my employees and helpers, the animal(s), the owner and/or the exhibitor of the animal(s) from the show and future show and the public reporting of disciplinary action, including to any association registered purebred livestock.

I release and agree to hold the show, the show organizers and its officials, directors, officers, employees, representatives, agents, and volunteers (collectively the "Show Organizers") harmless from an action taken under the agreement, the Minnesota Holstein Association Show Ring Rules and the Minnesota Holstein Association Show Ring Policy and Enforcement Procedures and any other Show rules and regulations, and release the show organizers from and against any injury, damage or loss suffered during or in connection with the show, whether or not such injury, damage, or loss resulted from or was contributed to, directly or indirectly, by the act or omission of the show organizers.
